Robin Hood, New York's largest poverty-fighting organization, finds, funds, and creates over 200 of the most effective programs, to help 1.8 million New Yorkers learn and earn their way out of poverty. Each year, Robin Hood reduces barriers to opportunities for nearly half a million New York City residents. From keeping more than 200,000 New Yorkers from going hungry, to helping more than 10,000 people secure jobs, to educating more than 55,000 students, to helping nearly 11,000 remain stably housed, Robin Hood is there for those in need.

While Robin Hood's primary focus is on New York, its impact extends beyond the city. The organization's metrics-based approach has been adopted by other charities around the nation, and the programs Robin Hood funds are often replicated in other cities.
